  - o Vote by ballot Tyler O'Dneal was elected.
- **Recording Secretary:** Maria Paula De Carolis, nominated by Mina Hosseini, vote passed unanimously.

Following the Election, Carolyn Nelson-Goedert assumed facilitation of the meeting.

## Region Updates and Announcements

- North Region Representative Reinaldo Palacios
  - o Processed many transfers. Online transfers are available parents can go online through the parent portal to do their transfer; they do not have to go to home school
  - o Parent advocates are available from 9:30 a.m. through 3:00 p.m. for any matters.
  - Mina Hosseini requested to invite the representative from FASCO Dr. Cabrera (Assistant Superintendent for Federal and State Compliance Office) to report on FISH capacity and provide reports of transfers, specifically to understand the movement of the student population across districts and regions.
  - Paula De Carolis requested an update on Exit Surveys to further understand the reasons for transfers and movement of the student population.
  - Paula De Carolis requested a report on whether the MDCPS Online Programs grew in student population, to better understand if immigration policy and safety could be determining student participation at the school site.
  - Leonora D. Stanford requested to look into the Archdiocese to identify if there is an
    increase in student population as compared to previous years, and if protections offered
    by religious institutions that are not available from the public sector are affecting
    enrollment.
  - Leonora D. Stanford requested to gather information on how MDCPS is promoting itself to attract more families outside the 2-mile radius.
- South Region Representative Wendy Fernandez
  - o The South region received information that enrollment is low, observed district-wide.
  - The region works tirelessly for parents to feel safe.
  - o Parent advocates are available to address any issues every day.
  - Venetian Park Academy is a new magnet school: currently opened for Pre-K-1st grades, accepting students, and will grow to expand and accommodate more grades.
  - Maria Ratti: There is a need for additional information on bus information and enrollment numbers.
  - Mina Hosseini requested that the region consider the opportunity for principals to engage in a conversation with parents prior to the execution of automatic transfers for retention purposes.
- Central Region Representative- Deborah Gonzalez
  - Central Region is processing parent choice applications and transfers, eliminating barriers and streamlining the process to help parents reach the goal of being where they would like to be.
  - The directors have been working for a smooth start to the year, processing applications and transfers.
- Legislative Updates Assistant Superintendent Office of Intergovernmental Affairs Tony Ullivari
  - o The following amounts have been secured for specific projects as follows:

\$ 500,000 for classical education \$500,000 Miami Arts Studio \$500,000 New World School of the Arts \$450,000 district-wide visual arts program (distributed equally; 50,000 for each district) \$350,000 space hub at Booker T. Washington High School

- MDCPS is gathering proposals to develop 2026 state and federal programs, which will be presented at the September 10 School Board Meeting. After finalization, proposals will be presented in Tallahassee and DC. Proposal lists could be revised during the process.

  - From September through December, training and orientations will be provided for all CIS/CLS of Title + I Schools.
  - Videos are being created to help navigate the website, to educate on language and parent-friendly videos, and to better understand Title \*I schools.
- HeadStart Program -Barbara Martin Galego
  - HeadStart is a free program for income-eligible families and is receiving applications from all families; income-eligible families have a higher priority. Please contact Ms. Barbara Martin Galego bmg@dadeschools.net / 305-995-7632
  - HeadStart serves 33 schools across the county and is a comprehensive wrap-around program where children from 0 to 5 years of age receive services to prepare them for kindergarten education.
  - HeadStart has many services like early interventionists, mental health, nutrition coordinators, and education coordinators to help the child and family and link them with the services they need.
